## IMPORTANT INFORMATION AND REVISION NOTES

---

A revised version of the *NSF Proposal & Award Policies & Procedures Guide (PAPPG)*, [NSF 11-1](#), was issued on October 1, 2010 and is effective for proposals submitted, or due, on or after January 18, 2011. Please be advised that the guidelines contained in [NSF 11-1](#) apply to proposals submitted in response to this funding opportunity. Proposers who opt to submit prior to January 18, 2011, must also follow the guidelines contained in [NSF 11-1](#).

**Cost Sharing:** The PAPPG has been revised to implement the National Science Board's recommendations regarding cost sharing. Inclusion of voluntary committed cost sharing is prohibited. In order to assess the scope of the project, all organizational resources necessary for the project must be described in the Facilities, Equipment and Other Resources section of the proposal. The description should be narrative in nature and must not include any quantifiable financial information. Mandatory cost sharing will only be required when explicitly authorized by the NSF Director. See the PAPP Guide Part I: *Grant Proposal Guide (GPG)* Chapter II.C.2.g(xi) for further information about the implementation of these recommendations.

**Data Management Plan:** The PAPPG contains a clarification of NSF's long standing data policy. All proposals must describe plans for data management and sharing of the products of research, or assert the absence of the need for such plans. FastLane will not permit submission of a proposal that is missing a Data Management Plan. The Data Management Plan will be reviewed as part of the intellectual merit or broader impacts of the proposal, or both, as appropriate. ## I. INTRODUCTION

---

Support of international activities is an integral part of NSF's mission to sustain and strengthen the nation's science, mathematics, and engineering capabilities. NSF recognizes the importance of enabling U.S. researchers and educators to advance their work through international collaboration and of helping to ensure that future generations of U.S. scientists and engineers gain professional experience beyond the nation's borders early in their careers.

Grants from the Office of International Science and Engineering (OISE) contribute to NSF's mission by supporting research and education activities that present unique opportunities and offer potentially high benefits through collaboration with scientists and engineers abroad. OISE support is intended to enhance current U.S. research capacity, develop a cadre of scientists and engineers who will play a leadership role in forging the international collaborations of the future, and broaden the participation of students, recent PhDs, early career faculty members, women, and minority and disabled scientists and engineers. NSF may consider proposals from U.S. institutions for collaborative work with any country that is not explicitly proscribed by the Department of State. Activities can be in any field of science and engineering research and education supported by NSF.

This solicitation offers support for the initial phases of an international collaboration with the strong expectation that the next phase will involve submission of a follow-on proposal for continued funding of the collaborative research. U.S. groups will be expected to develop a future proposal for continued funding that would be competitive in the merit-review process of the appropriate NSF program. Demand for funding of the follow-on international activities may generate new models and enhanced capabilities for supporting such projects.

To facilitate this end, it is required that **PIs establish communication with the cognizant OISE country Program Officer prior to submission to this solicitation. Failure to consult an OISE country Program Officer prior to submission may result in the proposal being returned without review.** (For a list of OISE Program Officers by country, see <http://www.nsf.gov/od/oise/country-list.jsp>.) ## II. PROGRAM DESCRIPTION

---

### Scope and Focus

This solicitation can support U.S. participation in a variety of different types of activities intended to catalyze **new** international

collaborations. These include, but are not limited to: planning visits, small workshops, initial data gathering activities, and the development of research coordination networks. The community is invited to propose innovative mechanisms and strategies for catalyzing new international collaborations to the stage that competitive research and education proposals can be submitted to relevant NSF programs for on-going support of the project. Any well-justified activity that fulfills the goals of the program will be considered. Creative use of technology in promoting international collaboration is encouraged. Funding levels for catalytic activities can typically range from as little as \$10,000 to as much as \$100,000, depending on the activities proposed.

Proposals submitted to this solicitation must include:

- Underlying research and education objectives of the proposed project and schedule of activities.
- Details on the complementary expertise of the U.S. and foreign partners; roles of all key individuals; expected contributions or involvement of the U.S. and foreign institution(s); information on the history of collaborative efforts with the foreign counterparts to date; and a description of the proposed division of labor among the participants.
- Ways in which U.S. students and early career researchers will be involved.
- Strategies and plans for continuing the collaboration; the specific NSF program to which a subsequent proposal would be submitted; and justification for why the proposed catalytic activity is necessary before submission of a subsequent proposal.

#### For PIs with Active NSF Awards

PIs with active NSF awards related to the topic of their planned catalytic activity may be eligible to seek funding for the activity by requesting a supplement to the existing award. These PIs should contact their cognizant disciplinary Program Officer and the OISE country Program Officer to discuss this option.

#### Additional Consideration

**Visas and Permits:** PIs are responsible for obtaining any required visas for foreign travel, and through the U.S. research institution, for providing documentation in support of U.S. visas for foreign counterpart investigators. PIs are also responsible for obtaining research permits and import/export documents, where necessary. ### III. AWARD INFORMATION

It is anticipated that approximately 40 awards will be made annually at a total investment of \$2 million, subject to the availability of funds. Awards will be standard or continuing grants.

1. **Proposal Cover Sheet.** Highlight this solicitation number in the program announcement/solicitation block and select "Catalyzing New International Collaborations" as the Program in the Unit Selection List. Grants.gov Users: The program solicitation number will be pre-populated by Grants.gov on the NSF Grant Application Cover Page. Grants.gov users should refer to Section VI.1.2. of the NSF Grants.gov Application Guide for specific instructions on how to designate the NSF Unit of Consideration. Check the box for "International Cooperative Activities Country Name" that appears under Other Information when the "remainder of cover sheet" is clicked, then select the countries involved.
2. **Project Summary** (one page maximum). Include the names and institutional affiliations of key foreign collaborators, and note their roles in the proposed activities. Intellectual merit and broader impacts anticipated from the international activity must be addressed in separate paragraphs.
3. **Project Description.** Describe how the activity will promote and develop new collaborative research with foreign partners. Include:
  - Underlying research and education objectives of the proposed project and schedule of activities.
  - Details on the complementary expertise of the U.S. and foreign partners; roles of all key individuals; expected contributions or involvement of the U.S. and foreign institution(s); information on the history of collaborative efforts with the foreign counterparts to date; and a description of the proposed division of labor among the participants.
  - Ways in which U.S. students and early career researchers will be involved.
  - Strategies and plans for continuing the collaboration; the specific NSF program to which a subsequent proposal would be submitted; and justification for why the proposed catalytic activity is necessary before submission of a subsequent proposal.

**If the proposal is for a workshop**, then it must also adhere to the special guidelines for Proposals for Conferences, Symposia, and Workshops given in the NSF Grant Proposal Guide Section II.D.8 [http://www.nsf.gov/pubs/policydocs/pappguide/nsf10\\_1/gpg\\_2.jsp#ID8](http://www.nsf.gov/pubs/policydocs/pappguide/nsf10_1/gpg_2.jsp#ID8). OISE does not provide support for U.S. scientists and engineers to participate in international conferences; nor does it provide support for such meetings. However, via this solicitation, OISE can support targeted workshops specifically designed to foster a new international collaboration that immediately precede or follow a larger-scale conference.
4. **Project Budget.** The budget justification should explain and justify major cost items. Funds may be requested to support catalytic activities, such as visits of U.S. faculty, postdocs, and/or students to counterpart foreign research groups, sharing of unique facilities or data, support for U.S. participants at workshops or special meetings, etc. Salary and stipend support, as well as major equipment costs, will only be allowed in exceptional cases. Funding levels will typically range from \$10,000 to \$100,000, depending on the type and scope of activities proposed.
5. **Supplementary Documentation.**
  - Biographical sketches for all principal foreign collaborators. All sketches must adhere to the format given in the Grant Proposal Guide (Chapter II.C.2.f, [http://nsf.gov/publications/pub\\_summ.jsp?ods\\_key=gpg](http://nsf.gov/publications/pub_summ.jsp?ods_key=gpg)).
  - Letters of commitment from collaborating foreign researchers and/or institutions.
  - Evidence of prior communication and consultation (e.g. copy of an email or synopsis of a telephone conversation) with the relevant OISE Program Officer indicating the appropriateness of the proposed activity for the Catalyzing New International Collaborations program.

#### **For PIs with Active NSF Awards**

PIs with active NSF awards related to the topic of their planned catalytic activity may be eligible to seek funding for the activity by requesting a supplement to the existing award. These PIs should contact their cognizant disciplinary Program Officer and the appropriate OISE country Program Officer to discuss this option.

#### **Other Budgetary Limitations:**

OISE funding can support the participation of U.S. principal investigators, contributing researchers, postdoctoral fellows, students and support staff, when specifically justified in terms of the international collaboration. OISE support for students and postdoctoral researchers is generally limited to U.S. citizens and permanent residents.

In most cases, foreign participants should obtain their own funding for participation in the collaborative project. However, when foreign participants are from a developing country, from a country whose economy is in transition, or from a country whose currency is not convertible, some support may be provided for the foreign participation. Applicants should discuss specifics with relevant OISE country Program Officers before submitting a proposal.

For living expenses abroad, applicants are encouraged to work with foreign counterparts to develop realistic budget requests. For example, access to university guest housing or similar facilities should be explored. In no case should the amount for lodging and meals and incidental expenses (MI&E) exceed the [authorized U.S. Government per diem rates](#), calculated at the daily rate for the first 30 days of a single project visit, and 50 percent of that rate for all time after that. Various approaches to cost-effective, reciprocal arrangements can be considered. By law, U.S. flag carriers must be used in accordance with the Fly America Act (see Chapter VI.G.1b of the NSF Award and Administration Guide at [http://nsf.gov/publications/pub\\_summ.jsp?ods\\_key=aag](http://nsf.gov/publications/pub_summ.jsp?ods_key=aag)).

**Submitting the Proposal:** Once all documents have been completed, the Authorized Organizational Representative (AOR) must submit the application to Grants.gov and verify the desired funding opportunity and agency to which the application is submitted. The AOR must then sign and submit the application to Grants.gov. The completed application will be transferred to the NSF FastLane system for further processing.

## VI. NSF PROPOSAL PROCESSING AND REVIEW PROCEDURES

---

Proposals received by NSF are assigned to the appropriate NSF program where they will be reviewed if they meet NSF proposal preparation requirements. All proposals are carefully reviewed by a scientist, engineer, or educator serving as an NSF Program Officer, and usually by three to ten other persons outside NSF who are experts in the particular fields represented by the proposal. These reviewers are selected by Program Officers charged with the oversight of the review process. Proposers are invited to suggest names of persons they believe are especially well qualified to review the proposal and/or persons they would prefer not review the proposal. These suggestions may serve as one source in the reviewer selection process at the Program Officer's discretion. Submission of such names, however, is optional. Care is taken to ensure that reviewers have no conflicts of interest with the proposal.

### A. NSF Merit Review Criteria

---

All NSF proposals are evaluated through use of the two National Science Board (NSB)-approved merit review criteria: intellectual merit and the broader impacts of the proposed effort. In some instances, however, NSF will employ additional criteria as required to highlight the specific objectives of certain programs and activities.

The two NSB-approved merit review criteria are listed below. The criteria include considerations that help define them. These considerations are suggestions and not all will apply to any given proposal. While proposers must address both merit review criteria, reviewers will be asked to address only those considerations that are relevant to the proposal being considered and for which the reviewer is qualified to make judgments.

**What is the intellectual merit of the proposed activity?**

How important is the proposed activity to advancing knowledge and understanding within its own field or across different fields? How well qualified is the proposer (individual or team) to conduct the project? (If appropriate, the reviewer will comment on the quality of the prior work.) To what extent does the proposed activity suggest and explore creative, original, or potentially transformative concepts? How well conceived and organized is the proposed activity? Is there sufficient access to resources?

**What are the broader impacts of the proposed activity?**

How well does the activity advance discovery and understanding while promoting teaching, training, and learning? How well does the proposed activity broaden the participation of underrepresented groups (e.g., gender, ethnicity, disability, geographic, etc.)? To what extent will it enhance the infrastructure for research and education, such as facilities, instrumentation, networks, and partnerships? Will the results be disseminated broadly to enhance scientific and technological understanding? What may be the benefits of the proposed activity to society?

Mentoring activities provided to postdoctoral researchers supported on the project, as described in a one-page supplementary document, will be evaluated under the Broader Impacts criterion.

NSF staff also will give careful consideration to the following in making funding decisions:

**Integration of Research and Education**

One of the principal strategies in support of NSF's goals is to foster integration of research and education through the programs, projects, and activities it supports at academic and research institutions. These institutions provide

abundant opportunities where individuals may concurrently assume responsibilities as researchers, educators, and students and where all can engage in joint efforts that infuse education with the excitement of discovery and enrich research through the diversity of learning perspectives.

#### **Integrating Diversity into NSF Programs, Projects, and Activities**

Broadening opportunities and enabling the participation of all citizens -- women and men, underrepresented minorities, and persons with disabilities -- is essential to the health and vitality of science and engineering. NSF is committed to this principle of diversity and deems it central to the programs, projects, and activities it considers and supports.

#### **Additional Review Criteria:**

In addition to the general NSF review criteria described above, the following criteria will be used in evaluating proposals submitted in response to this announcement:

1. Mutual benefits among partners; true intellectual collaboration with the foreign partner(s); and benefits to be realized from the expertise and specialized skills, facilities, sites, and/or resources of the international counterpart(s).
2. Active international research engagement of U.S. students and/or early career researchers.
3. Proposed activities likely to lead to potentially transformative contributions to research and education not possible without this catalytic step.

## **B. Review and Selection Process**

---

Proposals submitted in response to this program solicitation will be reviewed by Ad hoc Review and/or Panel Review.

Reviewers will be asked to formulate a recommendation to either support or decline each proposal. The Program Officer assigned to manage the proposal's review will consider the advice of reviewers and will formulate a recommendation.

After scientific, technical and programmatic review and consideration of appropriate factors, the NSF Program Officer recommends to the cognizant Division Director whether the proposal should be declined or recommended for award. NSF is striving to be able to tell applicants whether their proposals have been declined or recommended for funding within six months. The time interval begins on the deadline or target date, or receipt date, whichever is later. The interval ends when the Division Director accepts the Program Officer's recommendation.

A summary rating and accompanying narrative will be completed and submitted by each reviewer. In all cases, reviews are treated as confidential documents. Verbatim copies of reviews, excluding the names of the reviewers, are sent to the Principal Investigator/Project Director by the Program Officer. In addition, the proposer will receive an explanation of the decision to award or decline funding.

In all cases, after programmatic approval has been obtained, the proposals recommended for funding will be forwarded to the Division of Grants and Agreements for review of business, financial, and policy implications and the processing and issuance of a grant or other agreement. Proposers are cautioned that only a Grants and Agreements Officer may make commitments, obligations or awards on behalf of NSF or authorize the expenditure of funds. No commitment on the part of NSF should be inferred from technical or budgetary discussions with a NSF Program Officer. A Principal Investigator or organization that makes financial or personnel commitments in the absence of a grant or cooperative agreement signed by the NSF Grants and Agreements Officer does so at their own risk.

## **VII. AWARD ADMINISTRATION INFORMATION**

---

### **A. Notification of the Award**

---

Notification of the award is made to *the submitting organization* by a Grants Officer in the Division of Grants and Agreements. Organizations whose proposals are declined will be advised as promptly as possible by the cognizant NSF Program administering the program. Verbatim copies of reviews, not including the identity of the reviewer, will be provided automatically to the Principal Investigator. (See Section VI.B. for additional information on the review process.)

### **B. Award Conditions**

---

An NSF award consists of: (1) the award letter, which includes any special provisions applicable to the award and any numbered amendments thereto; (2) the budget, which indicates the amounts, by categories of expense, on which NSF has based its support (or otherwise communicates any specific approvals or disapprovals of proposed expenditures); (3) the proposal referenced in the award letter; (4) the applicable award conditions, such as Grant General Conditions (GC-1); \* or Research Terms and Conditions \* and (5) any announcement or other NSF issuance that may be incorporated by reference in the award letter. Cooperative agreements also are administered in accordance with NSF Cooperative Agreement Financial and Administrative Terms and Conditions (CA-FATC) and the applicable Programmatic Terms and Conditions. NSF awards are electronically signed by an NSF Grants and Agreements Officer and transmitted electronically to the organization via e-mail.

### **C. Reporting Requirements**

---

For all multi-year grants (including both standard and continuing grants), the Principal Investigator must submit an annual project report to the cognizant Program Officer at least 90 days before the end of the current budget period. (Some programs or awards

require more frequent project reports). Within 90 days after expiration of a grant, the PI also is required to submit a final project report, and a project outcomes report for the general public.

Failure to provide the required annual or final project reports, or the project outcomes report will delay NSF review and processing of any future funding increments as well as any pending proposals for that PI. PIs should examine the formats of the required reports in advance to assure availability of required data.

PIs are required to use NSF's electronic project-reporting system, available through FastLane, for preparation and submission of annual and final project reports. Such reports provide information on activities and findings, project participants (individual and organizational) publications; and, other specific products and contributions. PIs will not be required to re-enter information previously provided, either with a proposal or in earlier updates using the electronic system. Submission of the report via FastLane constitutes certification by the PI that the contents of the report are accurate and complete. The project outcomes report must be prepared and submitted using Research.gov. This report serves as a brief summary, prepared specifically for the public, of the nature and outcomes of the project. This report will be posted on the NSF website exactly as it is submitted by the PI.

NSF funds research and education in most fields of science and engineering.
